



# TERMS & CONDITIONS: VIC KIDS EAT WELL TERM ONE/SUMMER COMPETITION 2024 V2 VALID FROM 13TH FEB 2024



The following Terms and Conditions apply to the “Vic Kids Eat Well Term One/Summer Competition”, 2024

## CONDITIONS OF ENTRY

These Terms and Conditions include information on how to enter the Vic Kids Eat Well Term One/Summer competition and details of prizes. Participation in ‘Vic Kids Eat Well Term One/Summer Competition’ (this **Competition**) constitutes acceptance of these Terms and Conditions. Only entries that are submitted and comply with the below Terms and Conditions may take part in this Competition.

- 1) The Promoter is Cancer Council Victoria, 200 Victoria Parade, East Melbourne Victoria 3002 (**Promoter**), as part of the *Vic Kids Eat Well Program*. The Vic Kids Eat Well Program (**VKEW**) is supported by the Victorian Government and delivered by Cancer Council Victoria (CCV).
- 2) This Competition’s promotion period commences February 5<sup>th</sup>, 2024, 00:00:01am AEST and closes March 31<sup>st</sup>, 2024, 11:59:59pm AEST (the **Promotional Period**).
- 3) All organisations who register as a new member of Vic Kids Eat Well (**VKEW**) and submit 50 words or less outlining; ‘their most creative and innovative idea to foster a healthy food and drink environment in their organisation for kids this year’ during the Promotional Period, will be eligible to enter this Competition.
- 4) Organisations must not have previously joined VKEW to be eligible to enter this Competition.
- 5) For the purposes of this Competition, an eligible persons must be a staff member, volunteer, or canteen manager of a School, Sports Club, Outside School Hours Care, or Youth-focused Community Organisations that contains a food and drink environment. To be eligible, an organisation must be in Victoria, and provide/sell food and drink to young people between the ages of 5 and 18.
- 6) **To enter this Competition:**
  - a. Persons must be a staff member or canteen manager of an eligible organisation that registers as a member of **VKEW** during the competition dates;
  - b. There can only be one entry per organisation. If an organisation submits more than one entry, the first submission will be the eligible entry.



- c. Persons must enter this Competition by registering as a new **VKEW** member via the VKEW registration page and submit 50 words or less, outlining their most creative and innovative idea to foster a healthy food and drink environment at their organisation.
- 7) Incomplete, indecipherable or incomprehensible entries will be deemed invalid.
  - 8) The Promoter's decision in relation to any aspect of this Competition is final and binding on each person who enters. No correspondence will be entered into.
  - 9) The Promoter reserves the right to disqualify any entry where it reasonably suspects that such materials are prohibited by these Terms and Conditions, any relevant law, or otherwise deemed inappropriate. This is at the Promoter's absolute discretion and discussions will not be entered into. Entries that are considered unlawful, harassing, defamatory, abusive, threatening, harmful, obscene, profane, sexually orientated, racially offensive, contain objectionable content or are otherwise inappropriate will not be deemed valid and will be rejected.
  - 10) By entering this Competition, entrants' consent to receipt of emails regarding this Competition, and other emails which inform the entrant of the Promoter's other publications, products, services and events and promote relevant third-party goods and services.
  - 11) By entering this Competition, the organisation provides the Promoter and VKEW with permission to reproduce and use the organisation's name for purposes associated with promoting VKEW (such as, on social media platforms, website).
  - 12) This is a game of skill and chance plays no part in determining the winners. Each entry will be individually judged based on the merit of the information provided. The selection criteria "creativity" and "innovation" will be determined by the VKEW team at the offices of Cancer Council Victoria. Cancer Council Victoria will select the three best entries that are also deemed realistic ideas that organisations can implement to foster a healthy food and drink environment for children and young people. Judging will take place in the week commencing April 1<sup>st</sup>, 2024, by a VKEW panel of judges. There will be three winners. The three prize winners will be notified by email by the 25<sup>th</sup> of April and prizes will be sent via email by the 8<sup>th</sup> of May 2024.
  - 13) Cancer Council Victoria's [privacy policy](#) applies to this Competition.
  - 14) The Promoter will keep records of this Competition for 3 years.

**Prizes:**

- 15) There will be three prizes which will be chosen upon registration to Vic Kids Eat Well. Each prize is a \$200 e-voucher of the winners' choice between a Teacher Superstore e-voucher, Rebel Sport e-voucher or Kitchen Warehouse e-voucher.
- 16) There will be three individual winners of the prize draws and each organisation can only win one prize.
- 17) If winners do not identify which voucher they would like at the time of registration to Vic Kids Eat Well it will be auto selected by the Vic Kids Eat Well team.



- 18) The three prize winners will be notified by email by the 25<sup>th</sup> of April and prizes will be sent via email by the 8<sup>th</sup> of May 2024.
- 19) If, in any event, a winner does not want to accept the prize, or the Promoter is unable to locate a winner by 5pm the 1<sup>st</sup> of May 2024, the prize will be forfeited by the winner(s), with no liability whatsoever on the Promoter towards the prize winner(s).
- 20) Prizes are not transferable or exchangeable and cannot be redeemed for any other form of compensation (including cash), unless otherwise specified. The value of the prizes is accurate as at the commencement of this Competition. The Promoter and its associated parties accept no responsibility for any variation in the value of a prize after that date.
