

## TERMS AND CONDITIONS SPORTS CLUB COMPETITION



The following Terms and Conditions apply to the "Vic Kids Eat Well Sports Club Competition", 2023

## **CONDITIONS OF ENTRY**

Information on how to enter and details of prizes form part of these Terms and Conditions. Participation in the 'Vic Kids Eat Well Sports Club Competition (this **Competition**) constitutes acceptance of these Terms and Conditions. Only entries that are submitted and comply with these Terms and Conditions may take part in this Competition.

- The Promoter is Cancer Council Victoria, 615 St Kilda Rd, Melbourne Victoria 3004 (Promoter), as part of the Vic Kids Eat Well Program. The Vic Kids Eat Well Program (VKEW) is supported by the Victorian Government, and is delivered by Cancer Council Victoria's Achievement Program, in partnership with Nutrition Australia's Healthy Eating Advisory Service.
- 2. This Competition's promotion period commences June 6th 2023, midnight AEST and closes June 30th, 2023, midnight AEST (the **Promotional Period**).
- 3. All Victorian sports clubs who register as a member of Vic Kids Eat Well (VKEW) and submit 50 words or less, outlining 'what does your sports club plan to do to boost healthy and delicious food and drink options for kids?' during the Promotional Period, will be eligible to enter this Competition. Sports Clubs must not have previously joined VKEW to be eligible to enter this Competition.
- 4. To enter this Competition:
  - a. Persons must be a staff member, volunteer or canteen manager of a sports club that registers as a member of VKEW during the competition dates;
  - b. There can only be one entry per sports club. If a sports club submits more than one entry, the first submission will be the eligible entry.
  - c. Persons must enter this Competition by registering as a new VKEW member via the VKEW website and submit 50 words or less, outlining what healthy food options they want to see added to their sports club's canteen and why they think these are important for kids to have access to at their club.
- 5. Incomplete, indecipherable or incomprehensible entries will be deemed invalid.
- 6. The judges' and Promoter's decision in relation to any aspect of this Competition is final and binding on each person who enters. No correspondence will be entered into.







- 7. The Promoter reserves the right to disqualify any entry where it reasonably suspects that such materials are prohibited by these Terms and Conditions, any relevant law, or otherwise deemed inappropriate. This is at the Promoter's absolute discretion and discussions will not be entered into. Entries that are considered unlawful, harassing, defamatory, abusive, threatening, harmful, obscene, profane, sexually orientated, racially offensive, contain objectionable content or are otherwise inappropriate will not be deemed valid and will be rejected.
- 8. By entering this Competition, entrants' consent to receipt of any email regarding this Competition, and other emails which inform the entrant of the Promoter's other publications, products, services and events and promote relevant third-party goods and services.
- 9. By entering this Competition, the sports club provides the Promoter and VKEW with permission to reproduce and use the sports club's name for purposes associated with promoting VKEW (such as, on social media platforms, website).
- 10. This is a game of skill and chance plays no part in determining the winners. Each entry will be individually judged based on the merit of the information provided. The selection criteria "creative" and "innovative" will be determined by the VKEW team at the offices of Cancer Council Victoria who will select the 3 best suggestions based off the most realistic and creative ideas that sports can implement to foster a healthy food and drink environment for children and young people. Judging will take place in the week commencing July 3rd 2023 by a VKEW panel of judges. There will be three winners. The three prize winners prize will be notified by phone call and email by Friday August 11th 2023, 5:00pm AEST.
- 11. Cancer Council Victoria's privacy policy applies to this Competition.
- 12. The Promoter will keep records of this Competition for 3 years.

## Prizes:

- 13. There will be three prizes. Each prize is a \$250 e-voucher of the winners' choice between a Kitchen Warehouse e-voucher or a rebel sport voucher.
- 14. There will be three individual winners of the prize draws and each sports club can only win one prize.
- 15. The prizes will be transferred to the winners within 28 days after the end of the Promotional Period.
- 16. If, in any event, a winner does not want to accept the prize, or the Promoter is unable to locate a winner by 5pm Monday 23rd October 2023, the prize will be forfeited by the winner(s), with no liability whatsoever on the Promoter towards the prize winner(s).
- 17. Prizes are not transferable or exchangeable and cannot be redeemed for any other form of compensation (including cash), unless otherwise specified. The value of the prizes is accurate as at the commencement of this Competition. The Promoter and its associated parties accept no responsibility for any variation in the value of a prize after that date.
